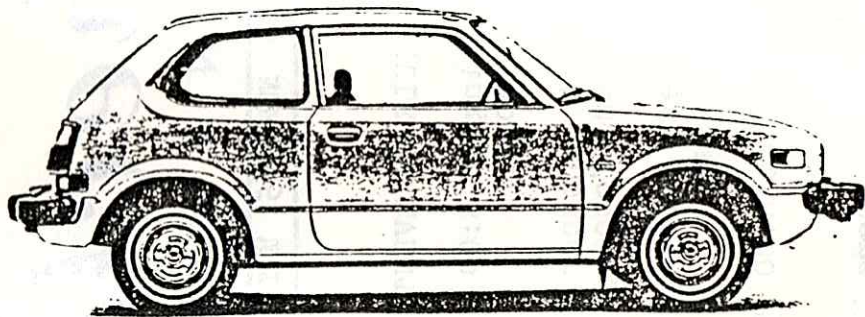

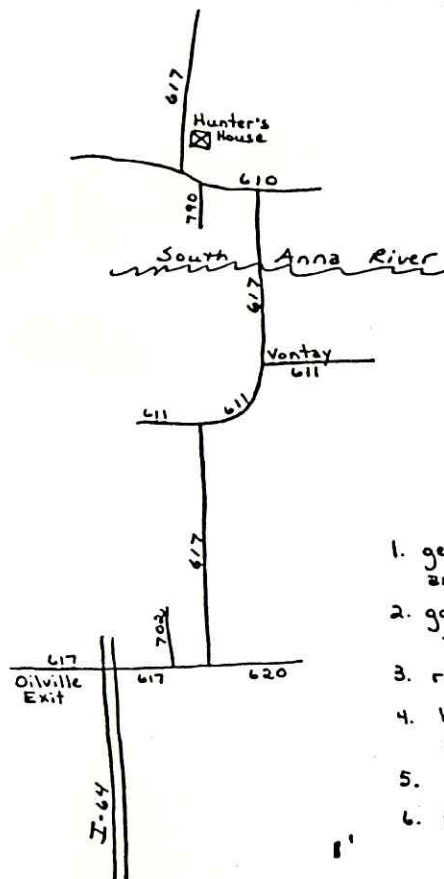

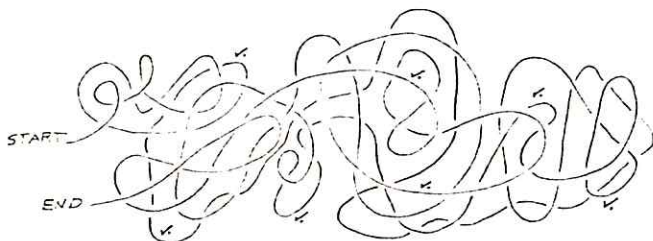
We dutifully fell for several traps but soon got the hang of it. It was gratifying to know that we did okay after the rookie hints stopped.
